SUPPLEMENTAL AGREEMENT/CONTRACT AMENDMENT NO. # 2

This SUPPLEMENTAL AGREEMENT/CONTRACT AMENDMENT is made by and between the STATE of MINNESOTA, acting through its Commissioner of Administration, "STATE," and, **Liesch Associates, Inc., 13400 15th Avenue North, Plymouth, MN 55441**, "CONSULTANT."

WHEREAS, STATE and CONSULTANT have entered into a contract, known as Department of Administration Contract No. **47710** for Industrial Hygiene Services for Asbestos and Other Hazardous Material Abatement Project Management, Testing, and Survey Master Contract; which was effective on July 1, 2012.

WHEREAS,

1. The original contract called for industrial hygiene services for asbestos and other hazardous materials abatement.
