- WHEREAS: President John F. Kennedy declared the first Law Enforcement Memorial Day on May 15, 1962, as a tribute to Peace Officers who lost their lives or were injured in the line of duty, and this day has been observed in our country annually since; and
- WHEREAS: Between 1881 and May 10, 2013, 270 Minnesota Law Enforcement Officers have been killed in the line of duty, with an average of 160 officers killed and 60,000 injured in the United States each year; and
- WHEREAS: The Minnesota Law Enforcement Memorial Association was established in 1974 to honor fallen and injured officers who put their lives on the line for the protection of all Minnesotans, dedicating a memorial at the Minneapolis/Saint Paul International Airport in 1977, before recreating the memorial on the Minnesota State Capitol grounds in 1995; and
- WHEREAS: On this Law Enforcement Memorial Day, the families of Minnesotans, Tom Decker, killed in the line of duty on November 29, 2012, and Josh Lynaugh, who died in the line of duty on February 16, 2013, will be dedicating the names of their loved ones on the National Law Enforcement Memorial in Washington D.C.; and
