**T O M O R R O W ' S   H O U S E H O L D S**

*Tomorrow's Households* reports household projections at five-year intervals through 2020 prepared by the Demographer's Office at Minnesota Planning. An overview of state trends by age, size and type of households is included with summary tables for state and county household projections.



## THE NEXT 30 YEARS

By the year 2020:

- Minnesota will have more than 2.1 million households, up from 1.7 million in 1990.
- One-third of all households will be married couples without children under age 18.
- Householders will be considerably older on average than they are now.
- Many rural areas will have fewer households than in 1990.
- One in 10 householders will be nonwhite.

American households have been changing rapidly in the past several decades. Fewer people are living in husband-wife families. More are living alone, in single-parent families or in nonfamily households. Minnesota household projections assume these trends will continue into the future, though at a less dramatic pace.

Household projections are prepared once every 10 years by the Demographer's Office at Minnesota Planning. Based on the 1990 Census, these projections reflect trends that occurred in Minnesota between 1980 and 1990.

*Minnesota's Changing Households* is the third of a four-part series on

*The Next 30 Years.* The first two publications dealt with state and county population trends. This volume presents state and county trends in the number and type of households. State data on age and race of householders are also provided. The last volume in the series will project the size, age and sex of the state's labor force as well as the size of each county's labor force.

Projections of households or occupied housing units are based on the

projected population figures appearing in earlier volumes in this series. They also reflect assumptions about changes in householder rates by age, sex and race.

The householder rate is the proportion of people in a particular age, race and gender group who are householders of a specified type. The accuracy of the household projections depends on the accuracy of both the population projections and the projected householder rates.

## DEFINITION OF TERMS

### Household:

Defined as an occupied housing unit. This unit may be a single-family home, apartment, mobile home or other type of housing. Group living situations, such as dormitories, prisons and nursing homes, are not considered households.

### Householder:

Based on the census form, households are classified according to the way the first person listed is related to other people living in the household. The first person listed on the form, who is called the "householder," is the owner or

renter of the housing unit. If more than one person owns or rents the unit, any one of them may be listed as the householder.

### Family Household:

If other people in the household are relatives of the householder, the household is considered a family household. Families may be married-couple (husband and wife) families or other families. Families also are classified according to whether they contain children under age 18. The classifications of families into those with and without children is based on whether

## AGING, SMALLER HOUSEHOLDS

Minnesota's population is projected to become older, more diverse and more concentrated in metropolitan areas. The same trends will hold for households.

During the next 30 years, the number of households in Minnesota is expected to grow almost twice as fast as the population. The number of households is projected to in-

the children are currently living in the home. If children are living elsewhere, or if they are all age 18 or older, the family is classified as a family without children.

### Nonfamily Household:

If the household does not contain anyone who is related to the householder, it is called a nonfamily household. The most common type of nonfamily household is a one-person household. The second type of nonfamily household has two or more unrelated people living together.

crease 28.7 percent between 1990 and 2020, compared to 15.5 percent growth in the number of people. By the year 2020, the number of households is projected to be 2,121,030, up from 1,647,853 in 1990.

The aging of the population is the main reason households are projected to grow faster than population. People in their 40s, 50s, and 60s are more likely to head a household than are younger adults. In coming decades, Minnesota will

see a big increase in the number of people in these age brackets.

Although the number of households will continue to grow substantially, the increases will be far less dramatic than in the past. In the 1970s, the number of households grew almost 25 percent. During the 2010s, the growth rate will fall to slightly less than 8 percent.

Future household growth will be more moderate for two reasons.

First, population growth is projected to be slower than in the past. Second, the total householder rate within each age, race and gender group is projected to remain stable, instead of increasing as it did in previous decades.


Average household size will continue to decline, but this change also will be smaller than in past decades. The average number of persons per household will drop from 2.58 in 1990 to 2.32 in the year 2020. By

comparison, the number of persons per household in Minnesota was 3.20 in 1970 and 2.74 in 1980.


**MARRIED-COUPLE HOUSEHOLDS GROWING SLOWLY**

Married-couple families are the most common type of household in Minnesota and will remain so. The number of married-couple households is projected to grow by 21

percent over the next 30 years. This is slower than the total rate of household growth. The shift away from husband-wife families to other living arrangements and the growth in the nonwhite population are factors behind the relatively modest growth in husband-wife households. Nonwhite people are less likely to live in married-couple households.


As the baby boomers grow older, more people will move into middle age, when the likelihood of being married is highest. Between 1990 and 2020, all the projected growth in married couples will occur among householders above age 45. A decline is forecast in the number of married couples under age 45.

Largely as a result of the aging of the population, the projections show


very different trends for married couples with children living at home compared to couples without children. As the population ages, there will be more "empty nest" couples whose children have grown up and left home. The number of couples living with children under age 18 is expected to decline about 8 percent, while the number of couples without children at home will grow about 48 percent.

By the year 2020, the number of husband-wife families without children under age 18 living at home will outnumber those who have children by a ratio of about 1.7-to-1. Only 20 percent of Minnesota households will contain married couples with children. By comparison, in 1970, couples with children under 18 made up 42 percent of all households and outnumbered couples with no children living at home by 1.4-to-1.

**GROWTH OF OTHER FAMILY TYPES TO VARY**

The number of single-parent families will grow substantially in the 1990s, but after 2000 the rate of increase will slow. Over the 30-year projec-

tion span, single-parent families will grow at a rate slightly below the rate for all households.

The relatively slow growth of single-parent families after 2000 is due to the aging of the population. People

over 45 are not likely to be single parents with children living at home.

Other family households that do not have children under 18 will show strong growth, increasing 61 percent between 1990 and 2020. Examples of other families without children under 18 include unmarried people living with adult children or elderly relatives. As with married couples without children under 18 living at home, the projected rapid increase can be traced to the aging of the population.

Other families with a female householder will continue to be much more common than those with a male householder but are expected to grow slightly slower.

**NONFAMILY HOUSEHOLDS**

Growth in the middle-aged and elderly population will spur a marked increase in one-person households in the next 30 years. The number of people living alone is projected to grow 43 percent between 1990 and 2020. The number of one-person households headed by someone 65 or older will grow even faster- 57 percent. By 2020, 12 percent of Minnesota households will consist of an elderly person living alone.

Nonfamily households with two or more unrelated people have grown rapidly in both Minnesota and the United States. Common examples of these households include cohabiting

couples and people living with roommates. The growth of this type of household is expected to be fairly strong during the 1990s, after which it is projected to be slower than the average growth for all households. Households containing two or more unrelated people are most common among younger adults, who are not a growing age group.

## EFFECT OF AGING POPULATION

The projected growth in the middle-aged and the elderly population will have a dramatic effect on Minnesota households. The average age of householders will increase markedly. In 1990, the median age of Minnesota householders was 44.2 years.

This is projected to increase to 52.9 years by the year 2020. Particularly marked gains in median age will occur among married-couple householders and persons living alone.

As the population ages, the number of families without children living at home and one-person households will grow. At the same time, the number of families with children and nonfamily households with two or more people will level off or decline.

## NONWHITE HOUSEHOLDS

Between 1990 and 2020, the projected number of white households will increase 20 percent, compared to 225 percent for nonwhite house-

holds. Households with an African American, Asian or Hispanic householder are all projected to triple, mirroring the rapid population growth of communities of color.

By 2020, 10 percent of Minnesota's householders will be nonwhite, up from 4 percent in 1990.

Gains in nonwhite households will be most evident among younger householders. In 2020, 22 percent of householders ages 15 to 24 are projected to be nonwhite, compared to only 4 percent of householders over age 65.

Nonwhite households will be most heavily represented among single-parent families. By 2020, 30 percent of single-parent families will have a

nonwhite head of household. In contrast, only 7 percent of married couples will be nonwhite in 2020. Both figures are considerably higher than they were in 1990. In 1990, 15 percent of single-parent families and 3 percent of married-couple families were nonwhite.

## CHANGES IN HOUSEHOLD DISTRIBUTION

In spite of all the changes in Minnesota households over the next 30 years, the distribution of household types in 2020 will not differ extremely from the current pattern. Married couple households will still account for more than half of all households, though there will be a

sharp shift from couples who have children at home to couples who do not. One-person households will remain the second most common household type, representing more than a quarter of all households. The shares of the other types of households will not change dramatically.

Households are projected to grow fastest in the Twin Cities suburbs. This reflects the rapid population growth anticipated in those areas.

At the other extreme, some rural counties are projected to have substantial household losses, with several counties having declines in every category of household.


The future household distribution of Minnesota counties is closely tied to projected shifts in the age distribution. Differences in householder rates also play a role. For instance, nonfamily households make up a large proportion of the households in Min-

neapolis and St. Paul, while married couples make up a large share of the households in Twin Cities suburbs.


By the year 2020, married couples with children will account for less than one-fifth of the households in Hennepin and Ramsey counties and in most of northeastern Minnesota. Suburban counties will have the highest proportions of couples with children.

Most of southwestern Minnesota will see a decline in the number of one-person households, a function of the anticipated decline in their older population. Large increases in one-person households are anticipated in the Twin Cities suburbs and in the St. Cloud and Rochester areas. In recent years, these areas have attracted many middle-aged people. In the next three decades, many of these people will become widowed or divorced and will be living alone.

Although one-person households will grow faster in the Twin Cities and other growing urban areas, the greatest concentration will remain in southwestern Minnesota. Older people make up a large proportion of the population in these areas, and older people are most likely to live alone.

Southwestern Minnesota is projected to have the smallest proportion of single-parent families in 2020. The

highest concentration of single-parent families is projected to occur in the North Central region.

## METHODOLOGY

The projected number of households is the product of the projected population and the proportion of people in each age and sex group who are projected to be householders.


At the state level, household projections were done separately for each race, using the projected population from *A Changing Population: The Next 30 Years*. The state household numbers were derived by adding together the projected number of households for the five racial groups.

The projections assume that the total householder rate in each age, sex and race group will remain constant over time. For example, the prob-


ability that a 25- to 29-year-old white man will be a householder is held constant at .473 at all times during the 30-year period.

Householder rates are closely related to the availability of affordable housing. More people can establish independent households if housing costs are relatively low. Many economists believe that long-term real interest rates will remain low. This would make housing more afford-

able. On the other hand, real wages have stagnated, making housing less affordable. The projections assume these trends will balance out and that the availability of affordable housing (and householder rates) will remain fairly stable over time.

Although the total householder rate is projected to remain constant, the rates for individual household types will shift away from married couple households to nonfamily households

and families other than married couples. This shift in living arrangements has been going on for several decades.

The first step in calculating the projected householder rates was to estimate the householder rates by age and sex for 1980 and 1990 for four major household types: married couples, other families, nonfamily households with one person and nonfamily households with two or more


people. Some modifications had to be made because the 1980 data on married-couple householders were not exactly the same as the 1990 data.

The projections assume that householder rates by age and sex will change at 40 percent of the 1980-1990 change level between 1990 and 2000. Between 2000 and 2010, they were assumed to change at 20 percent of the 1980-1990 rate. After


2010, householder rates were assumed to be constant.

An additional modification was to average the married-couple householder rates for men and women in each age group. In theory, either the husband or the wife can be the householder in married-couple families. In practice, the husband is usually listed first on the census form and is therefore counted as the householder. Over time, however,

more married women have been listing themselves first. If the male and female rates are not averaged, the householder rate changes between 1980 and 1990 are misleading because they represent not only real change in household type but also change caused by more married women listing themselves as the householder.

The projections assume that householder rates will vary by race, as they did in 1990. The rates of change are assumed to be constant across races, however.

After applying the projected rates of change, the projected householder rates for each of the four major household types (married couples, other families, one-person households and nonfamily households with two or more people) were

summed and compared to the total 1990 householder rate for that age, race and sex group. The projected rates for the four householder types were then adjusted so they added up to the 1990 total householder rate.

For family households, the proportion of families with and without children under 18 living at home was calculated for 1990. This proportion varies by age of householder. Among noncouple families, it also varies by gender. The proportion of family households with children was kept constant at 1990 levels.

The 1990 census data on families with children contain limited information on age of householder. Data are given only for four broad age groups: 15 to 24, 25 to 34, 35 to 44 and 45 and older. The figures for householders over 45 were adjusted

so that the proportion who have children declines with advancing age. For example, family householders ages 45 to 49 are given a higher probability of having children living with them than those ages 65 to 69.

County projections were done in two steps. First, the 1990 county-specific householder rates by age and gender were multiplied by the projected population county population by age and gender reported in *Minnesota's Changing Counties: The Next 30 Years*. The county numbers for each age and sex group and household type were then added together and compared to the state total derived earlier for the same age and sex group. The county numbers were then controlled to the state totals by taking the ratio of the state total to the sum of the county totals

and multiplying each of the county numbers by this ratio.

The procedure for deriving the uncontrolled projections in Hennepin and Ramsey counties was slightly different. These counties together contained about two-thirds of the state's minority population in 1990, and it was assumed that they would be most affected by the anticipated growth in this population. The projected household change solely attributable to racial composition was distributed to these two counties in proportion to their 1990 share of the minority population. In other words, 42.9 percent of the change attributable to race was assigned to the Hennepin County uncontrolled total, and 23.7 percent was assigned to the Ramsey County uncontrolled total.


**COUNTY HOUSEHOLD PROJECTIONS: 1990 TO 2020**






