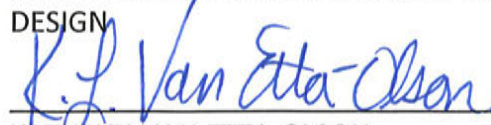
1. The Board of Architecture, Engineering, Land Surveying, Landscape Architecture, Geoscience and Interior Design ("Board") received a Notice of License Revocation from the Minnesota Department of Revenue ("Revenue") on April 3, 2006 which advised the Board that Edward Lukacsek ("Respondent") had an outstanding tax liability. Under Minn. Stat. § 270C.72 (2024), the Board must revoke Respondent's license.
2. The Board revoked the Professional Engineer license of Respondent on April 20, 2006.
3. The Board received a License Clearance Certificate from Revenue on October 30, 2025, indicating that the Board may now issue, renew or transfer this license.
4. In compliance with the Order for Revocation of Professional Engineer issued on April 20, 2006, if a Tax Clearance Certificate is received, the Board shall then issue an Order to rescind the revocation of Respondent's Professional Engineer license.

**ORDER**

It is hereby ordered, pursuant to the Minn. Stat. § 270C.72, subd. 1(c) (2024), that the revocation of Respondent's Professional Engineer license is rescinded.

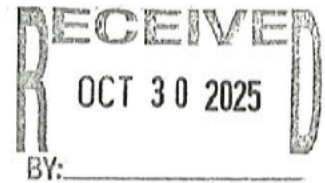
