CONTENT: The Developmental Disabilities Act Amendments
of 1987 (Section 122(b)(2)(C)) require that the
activities described in the Two Year Transitional
State Plan be reviewed by the State Planning
Council and designated State Agency on an annual
basis. In accordance with Section 1386.31(a) of
the regulations, any changes in the State Plan
proposed for FY 1991 should be submitted to the
appropriate Regional Office no later than
August 15, 1990. If there are to be no major
changes in the Two Year Transitional State Plan
for FY 1990, please inform the Regional Office.

In addition, Section 122(b)(2)(D) of the Act requires that each State "for each Fiscal Year, assess and describe the extent and scope of the priority areas (as defined by Sections 102(10), (11), (12), (13), (14), (15), and (16)) which are addressed or will be addressed under the plan in the Fiscal Year". If you have not already done so, please submit this information, along with a FY 1991 budget, to the appropriate Regional Office.
