
**SUBJECT:** Fiscal Year 1993 Federal Allotments to States

**Federal Allotments to States for Developmental Disabilities, Basic Support, and Protection, and Advocacy Formula Grant Programs for Fiscal Year 1993**

**AGENCY:** Administration on Developmental Disabilities, Administration for Children and Families, Department of Health and Human Services.

**ACTION:** Notification of fiscal year 1993 federal allotments to States for developmental disabilities basic support and protection and advocacy formula grant program.

**SUMMARY:** This notice sets forth the individual allotments to States for Fiscal year 1993, pursuant to section 125 of the Developmental Disabilities Assistance and Bill of Rights Act (Act). The allotments to the States published herein are based upon Fiscal Year 1992 funding levels, and are contingent upon Congressional appropriations for Fiscal Year 1993. If Congress enacts and the President approves an amount different from the Fiscal Year 1992 funding levels, the allotments will be adjusted accordingly.

**EFFECTIVE DATE:** October 1, 1992.

**SUPPLEMENTARY INFORMATION:** Section 125(a)(2) of the Act requires that adjustments in the amounts of State allotments may be made not more often than annually and that States are to be notified not less than six (6) months before the beginning of any fiscal year of any adjustments to take effect in that fiscal year.

The Administration on Developmental Disabilities has updated the data elements for issuance of Fiscal Year 1993 allotments for the Developmental Disabilities formula grant programs. The data elements used in the update are:

A. The number of beneficiaries in each State and Territory under the Childhood Disabilities Beneficiary Program, December 1990, are from Table 5.J10 of the "Social Security Bulletin: Annual Statistical Supplemental 1991" issued by the Social Security Administration, U.S. Department of Health and Human Services. The

numbers for the Northern Mariana Islands and the Trust Territories of the Pacific Islands, included under 'Abroad' in the Table, were obtained from the Social Security Administration;

B. State data on Average Per Capita Income, 1985-90, are from Table 1, page 30 of the "Survey of Current Business," August 1991, issued by the Bureau of Economic Analysis, U.S. Department of Commerce; comparable data for the Territories also were obtained from that Bureau; and

C. States and Territories total population are from the 1990 Census Population Counts. Data for the States were issued in the U.S. Department of Commerce, Bureau of the Census report entitled, "Census Population—Housing" (CPH-L-4, Summer 1991); and the Territories data were issued individually by "Census Bureau Press Releases" (CB91-142, CB91-242, CB91-243, CB91-244, CB91-263, and CB91-276, July, 1991). States' data for the Working Populations (ages 18-64) are also based upon the 1990 Census Population Counts. The Territories Working Populations were issued in the Bureau of Census report, "General Characteristics Report: 1990," which is the most recent data available from the Bureau.
