The Comprehensive Plan of Action, approved and adopted by the Court on March 12, 2014 (Dkt. 284) mandates a specific coordinated process for planning and implementation of supports for each person covered by the CPA.


The Department of Human Services endorses this presentation. Plaintiffs have not objected.
