The Court is in receipt of Defendants' request to reschedule the status conference currently scheduled for July 13, 2020.<sup>1</sup> (Doc. No. 848 ("Request").) The Court grants the request insofar as the status conference is postponed until September 24, 2020 at 9:00 AM.<sup>2</sup>

Jurisdiction is currently scheduled to end on September 15, 2020. (Doc. No. 737.)

To ensure an opportunity for each party to be heard with respect to Dr. Gary LaVigna's forthcoming report regarding the use of mechanical restraint at the Forensic Mental Health Program and Anoka Regional Treatment Center,<sup>3</sup> and to review other reports submitted since the last status conference, the Court deems it just and equitable to extend its jurisdiction until October 24, 2020.<sup>4</sup> Notwithstanding, the Court expressly reserves the authority and jurisdiction to order an additional extension of jurisdiction, depending

Defendants state that they are unavailable July 12-24; however, they suggest that the conference be held on an alternative date in July. (Request.) Due to previously scheduled trials and hearings, the Court is unable to accommodate Defendants' preferred dates.

In light of the Court and Defendants' schedules, September 24, 2020 is the earliest the conference may occur.

Due to the COVID-19 pandemic and the additional barriers it posed to communicating and sharing documents, the Court extended the deadline for Dr. Gary LaVigna to submit his report regarding the use of mechanical restraint at the Forensic Mental Health Program and Anoka Regional Treatment Center until June 30, 2020. (Doc. No. 836.)

Pursuant to the Settlement Agreement § XVII.B, and the Eighth Circuit's ruling, this Court may extend its jurisdiction as it deems "just and equitable." (<u>Doc. No. 136-1</u> § XVII.B; <u>Doc. No. 695 at 12</u>.) Here, the Court finds that an extension until October 24, 2020, approximately one month after the September 24, 2020 status conference, is necessary to respond to what occurs during the status conference and to properly determine whether its jurisdiction may at last come to a just and equitable end.

upon the status of Defendants' compliance and absent stipulation of the parties. Until the

Court's jurisdiction ends, all reporting requirements remain unchanged.

**ORDER** 

Based upon the presentations and submissions before the Court, and the Court

being otherwise duly advised in the premises, IT IS HEREBY ORDERED that:

1. The status conference shall be held on September 24, 2020 at 9:00 AM in

2. The Court's jurisdiction is extended to October 24, 2020. The Court

stipulation of the parties.
