Introduction Hal Kennedy, Esq.

Willowbrook State School was built in the 1930's in Staten Island, NY to < for individuals with mental retardation and developmental disabilities. It does not receive its firs residents, however, until after World War II. A combine of rising placements, budget cuts, ignorance, arrogance and indifference, created notorious conditions at Willowbrook. By 1965, with over 6,000 residents in an institution planned for just 4,000, Senator Robert Kennedy calling Willowbrook a "snake pit." In November 1971, The State Island Advance published a series of articles detailing the horrible conditions at the school. Following these articles, in January 1972, Geraldo Rivera, the television reporter, began a series of programs that shook the conscience of New York State and the nation and inspired parents and others to take legislative action. The end result was the signing of a consent judgement in federal cc in 1975. Willowbrook finally closed its doors in 1987.

The Consent Judgement has been called "revolutionary" because of what is accomplished and for what it inspired. The closure of Willowbrook, the placement of individuals with developmental disabilities in community

residences, the growth of voluntary agencies and the expansion of day programs and special education can all be linked to the Judgement. The Judgement finally recognized and enforced the rights of individuals with mental retardation and developmental disabilities. The Judgement is the mean used throughout the United States and in many parts of the world.

Dr. William Bronston, MD worked as a staff physician at Willowbrook (from 1970-1972) and was dismissed after agitating for change. Later he was a s1 witness in a legal case brought by parents to improve conditions at the School This collection includes the evidence he presented in court and other material he gathered and includes photographs, legal documents and case histories. Significant portions of the collection are slated to be digitized as part of the Disability Rights and Independent Living Movement collection.

David J. and Sheila M. Rothman wrote *The Willowbrook Wars*; these records are the Rothmans' research files on the Willowbrook case. Included are publications relating to mental health care and photocopies of reports, memoranda, legal briefs, correspondence, and other records from official sources (such as: the State Office of Mental Health and Mental Retardation Willowbrook Review Panel, and New York City mental health agencies). available are an extensive number of community placement files that include information on individual cases, reports on other community placement programs, reports on the Willowbrook community placement program, leg papers on community placement, and duplicate copies of professional literacy on community placement.

Staten Island Developmental Center. Patient Case Files, 1950-1980. 246 cu. ft.

This series consists mostly of case files of patients who died while residing Willowbrook. The case files document patients' admission, treatment, there and education. Case files typically contain: admission phase sheets, record visitors and correspondents, ward admission records, legal admission record psychiatrists' psychological reports, Willowbrook school reports, physical examination information, progress notes by doctor, social service notes by social worker, laboratory notes, consultation requests (for x-rays, etc.) signed by doctor, prescription records, nurses' notes, dental and weight charts, clothing lists, and correspondence from other institutions.

Access permanently restricted in accordance with Mental Hygiene Law relating to confidentiality of clinical records.

Willowbrook Review Panel Records, 1970-1985.

In 1975, newly elected Governor Hugh L. Carey signed the Willowbrook Consent Decree, a civil rights law that obligated New York State to provide appropriate housing and programs for more than 6,000 individuals at Willowbrook State School. The law established the Willowbrook Review Panel, a temporary federal authority to oversee the transfer of residents fro the Willowbrook Center to group homes. These records document the work the review panel over a twelve year period and capture a significant aspect the history of New York state mental health policy and include reports from monitoring agencies, complaints, correspondence, meeting minutes, and re research materials. The collection is currently unprocessed and closed. A good is underway to process and create a finding aid for the collection. The collection will be available for access in January 2005. Some materials ma restricted due to privacy. Questions should be forwarded to the Head of the M.E. Grenander Department of Special Collections and Archives.

He represented the City Service Employees Association in *State of New York Departments of Mental Hygiene, Agriculture and Markets, Health, and Transportation and New York State hospitals at Rockland and Willowbrook vs. Civil Service Employees Association.* (1972-1975) on issues of improper personal conduct, discipline negligence, dismissal, fringe benefits, and insubordination.
