WHEREAS, 1984 HAS BEEN DESIGNATED THE INTERNATIONAL YEAR OF THE DISABLED PERSON, AND UPON THIS OCCASION, PROJECT INTERDEPENDENCE IS DESERVING OF SPECIAL RECOGNITION AND HIGHEST COMMENDATIONS; AND

WHEREAS, ONE OF THE GOALS OF PROJECT INTERDEPENDENCE IS TO BREAK DOWN THE LABELING AND STEREOTYPING ASSOCIATED WITH "HANDICAPPISM"; AND

WHEREAS, THE DEDICATED STAFF OF PROJECT INTERDEPENDENCE HAS CREATED THIS PROGRAM IN 18 HIGH SCHOOL DISTRICTS STATEWIDE IN AN EFFORT TO EXPOSE THE DESTRUCTIVE IMPACT OF "HANDICAPPISM" THAT IS PREVALENT THROUGHOUT OUR SOCIETY; AND

WHEREAS, PROJECT INTERDEPENDENCE SEEKS TO DEMONSTRATE THE VALUE AND ECONOMY OF PUBLIC AND PRIVATE PARTNERSHIPS WHERE CORPORATE-ORIGINATED PUBLIC SERVICE CONTRIBUTIONS CAN BE USED IN THE PROGRAM AND ITS EDUCATIONAL MEDIA PRODUCTS; AND


