#### SCOPE:

Regional MR Program Managers County MH/MR Administrators Base Service Unit Directors

#### PURPOSE;

To announce that the Office of Mental Retardation will accept proposals from counties for funding to initiate family-driven family support services pilot projects.

### INTRODUCTION:

A primary mission of the Department of Public Welfare is to promote, improve, and sustain the quality of family life. The basis of this the family is the primary unit for nurturing emotional mission is that support, economic support, socialization, and care of its members, including those with mental retardation. County mental retardation programs should acknowledge and enhance the role of the family as the primary responsible unit for caring for members with mental retardation and should assist families in providing a supportive, nurturing environment so that out-ofhome placements are minimized.

The Office of Mental Retardation expects that community mental retardation programs, which focus on families, will be designed and managed in order to achieve optimal quality. The Office of Mental Retardation will oversee and support county management towards achieving this goal.

#### BACKGROUND:

It is the goal of the Office of Mental Retardation and the Department to assure that parents and caretakers have the supports necessary to accept responsibility for providing a nurturing environment for their family members with mental retardation.

Nationally, Pennsylvania is recognized as having a comprehensive array of support services for families. These family and client services include, but are not necessarily limited to: respite care, sitter/campanionship services, homemaker services, in-home support, aural rehabilitation, hearing aid evaluations, sign language training, physical therapy, occupational therapy, mobility training, behavioral programming, home rehabilitation, adaptive appliances, and special diets. With the assistance of these types of services, many persons with mental retardation have been able to live successfully in the community.

Within the service system, however, there frequently exists a lack of direct and meaningful family involvement in the decisions about the services the family needs, receives, is aware of or has access to. For a variety of reasons, families often have little choice in regard to which services are planned or delivered because their needs are frequently identified and assigned priority by others. OMR intends to enhance family participation in decisions regarding which services will best address family needs by stimulating the development of family-driven family support services projects in a number of counties throughout the state.

During June of 1987, as an important component of this effort OMR, in conjunction with the Pennsylvania Association of Resources for People with Mental Retardation, sponsored four seminars across the state to acquaint counties, providers, parents/families, advocates, and consumers with the family-driven method of providing family support services. OMR has also established a broadly representative subcommittee of its Planning Advisory Committee to assist the Office in designing new ways to make family support services available to persons with mental retardation and their families. The Subcommittee on Family Support Services will continue to have an important role in the initiation of family-driven projects throughout the state. Through the issuance of this Request for Proposals (RFP), OMR is now providing county mental retardation programs the opportunity to apply for funding to initiate a family-driven family support services pilot project.

## NOTICE OF PREPROPOSAL CONFERENCE:

The Office of Mental Retardation will conduct a preproposal conference to review and clarify the purpose of this effort and the requirements of the Request for Proposals and to respond to questions which potential applicants may have regarding this effort. The preproposal conference will be held on October 15, 1987 from 10:00 a.m. to 1:00 p.m. in the Heritage Room B of the Department of Education Building, 333 Market Street, Harrisburg, Pennsylvania.

All counties interested in applying for these special funds should have a representative attend this important meeting. Due to the tight timeframe for initiating projects, there will be no opportunity to send records of discussion at the proposal conference to counties not in attendance.

#### THE REQUEST FOR PROPOSALS (RFP):

#### I. Purpose

The purpose of this RFP is to request proposals from counties for categorical funding from the Office of Mental Retardation to initiate family-driven family support services pilot projects. Through these projects, counties should demonstrate service expansion to currently unserved and/or underserved persons with mental retardation and their families.

#### II. Definitions

For the purpose of the RFP, the following definition is applicable:

A. Family-Driven - refers to a method of providing services whereby the family and the person with mental retardation, rather than the service system, are given the responsibility for deciding which services will best address the family's specific needs.

#### III. Eligible Applicants

Applications will be accepted only from County Mental Retardation Programs and must be signed by the County MH/MR Administrator.

#### IV. Funding

The Office of Mental Retardation intends to make a total of \$658,000 in half-year funding available to support eight or more family-driven pilot projects in eight or more different county programs beginning in the third quarter of Fiscal Year 1987-88. Funding for each project will be provided on a 100%E State funding basis. Categorical funding for projects initiated in Fiscal Year 1987-88 will be annualized on a full-year funding basis for Fiscal Year 1988-89. It is expected that funded projects will be operational by the end of the third quarter of Fiscal Year 1987-88. During Fiscal Year 1988-89, OMR will evaluate each project. On-going funding for the projects beyond Fiscal Year 1988-89 will be based on the results of the evaluation and will be included in the non-residential base allocations of participating counties.

#### V. Required Guiding Principles for Proposals

All proposals must demonstrate the following principles in their plans for empowering families in the provision of support services to them:

- A. Families must be directly and meaningfully involved in planning, implementing, monitoring, and evaluating the provision of supports to them.
- B. Families must be consistently educated about which services exist and are available initially and throughout the project.
- C. Good human services should be guided by a clearly stated mission/purpose.
- D. Local community resources and informal supports typically used by or available to all members of a given community should be used to the extent feasible to avoid service duplication or the creation of another layer of specialized services.
- E. Service delivery should promote client growth and development and result in family/client satisfaction.

#### VI. Suggested Models

The Office of Mental Retardation has identified four family-driven approaches which would be eligible for funding as a pilot demonstration project. County applicants should propose to initiate a project which demonstrates one or more of these models. OMR would also consider proposals which describe other family-driven approaches not described below if such models clearly demonstrate the guiding principles listed above in Section V of this RFP. The four family-driven models suggested by OMR are:

- A. Cash Payment this method involves providing a cash payment directly to the family. The family may use the money only for services eligible under the MH/MR Act of 1966.
- B. Voucher this method involves establishing a voucher system to be used as payment for services. The voucher might be used for payment, or payment could be made to the family after submission of a receipt for services.
- C. Traditional Funding/Preapproved Service Plan this is the model currently being tested widely in Allegheny County. It involves an allowance for a certain amount of services based on an annual need review and a preapproved plan. Payment for the services is made by the County or its designee. The family receives no money or vouchers to purchase services.

D. Informal Supports - this method involves making funds available to hire a community organizer who would develop a system that would provide services, material or financial assistance for the family through friends, relatives, or community groups. Service clubs and church groups would be prime candidates for providers of informal supports such as friendly visiting, shopping assistance, respite care co-ops, companion services, etc. Informal supports would be provided in addition to, and not as replacement for, traditional services.

#### VII. Timeframe for Submission of Proposals

To be considered for funding, two (2) completed proposals (applications) must be sent or delivered to the appropriate Regional MR Program Manager so that they are received in the Regional Office by 5:00 p.m. on November 4, 1987.

Counties must also send or deliver a copy of each proposal to Mr. Arthur R. Geisler, Office of Mental Retardation, Room 302 Health & Welfare Building, Harrisburg, Pennsylvania, 17120, by 5:00 p.m. on November 4, 1987.

#### VIII. Proposal Format and Application Requirements

Counties should use the attached application to submit a proposal for funding to initiate a family-driven family support services pilot project described in this RFP. Insofar as it is possible, applicants should respond to each question within the space limitations provided. Responses to the questions should be consistent with the policies and procedures set forth in Mental Retardation Bulletin #99-86-08 entitled Quality Assurance in Community Mental Retardation Programs.
