## SUBJECT: Toilets at State Hospitals

Last year's Ward Living Survey report identified that we have 508 toilets in the system without seats, covers, etc. In this regard, I have set as a high priority this problem throughout the system during this fiscal year. The administrators, at our meeting on June 28, agreed that every effort would be made to correct this problem on their campus during the next 12 months:

In this regard, I am aware that the Brainerd staff have developed a heavy plastic cover-seat, etc. If such is workable at Brainerd, it may be something that may be considered for other campuses as well.
  - 4. The design of the toilet-toilet covers at the Security Hospital may pose a special problem because of safetysecurity reasons.
- Request: In cooperation with the administrator and other appropriate staff will you ascertain the validity of the above and develop a plan directed toward correction of the problem? The plan should reflect the number of toilets that will need to be replaced; the number where seats-covers, etc., will need to be installed; a projection giving estimated costs of accomplishing the work to be done (NOTE: In some instances, tile -- plumbing -- pipes, etc., may need to be replaced). I would like to have a report covering the above by September 1, 1973, along with a timetable when such will be accomplished at each facility.
- NOTE: As a guide in accomplishing the above -- plan for the corrective action in any building where you and the administrator judge the building will be in use at least until September 1, 1975.
