SUBJECT:

EDS update and submission of PPRs on January 1, 1999.

DISCUSSION:

ACF has made a decision on an alternative to its JetForm Filler as the software for electronic data submission (EDS). We are now moving forward on implementing a EDS system based on the more widely used Adobe Acrobat portable document format (PDF) technology found on the Internet. To use this new approach, ADD is developing PDF forms, which you will be able to access

over the Internet.

Unfortunately, the Adobe EDS system will not be operational for the submittal of program reports due January 1, 1999. Therefore, the following required reports (See IM-98-6 and IM-98-7) due January 1, should be submitted in hard copy:

- (1) PPR from Councils
- (2) PPR from P&A

In order to accommodate the new Adobe EDS, the recommended systems requirements are:

Macintosh

- Power Macintosh
- 16 MB of available RAM
- Apple System Software version 7.1.2 or later
- CD-ROM Drive
- 40 MB of available hard-disk space

IBM or Compatible PC for Windows

- Pentium or Pentium processor-based PC
- Windows 95 or Windows NT
- 16 MB of RAM (24 for Windows NT)
- CD-ROM Drive
- 50 MB of available hard-disk space

It is anticipated that the use of the Adobe Acrobat software will permit network programs more flexibility in the processing, transmission, and access to data submitted to ADD.

In order to afford our network programs increased input into the further development of our EDS system and its accompanying software; ADD has constituted a EDS Users Group. (See attachment for listing of members.) The Users Group's primary objective will be to review the new system's software, provide testing sites and give feedback to ADD on the system's merits. In addition, the Users Group has agreed to assist ADD in the development of an Action Plan that will allow feedback and technical assistance to the program network on an ongoing basis.

Responses from our initial Users Group meeting were positive and reinforced ADD's commitment to the EDS system. A list of the Users Group members is attached for your information. Feel free to contact them for individual comments.

During the interim period of redesign and pilot testing of this new EDS software, each Council and P&A should prepare and submit to ADD a <u>hardcopy</u> of their respective PPR by January 1, 1999.
