Home and Community Based Services Programs provide funding for services that are necessary for an individual to remain in the community and avoid being placed in an institution. The following is a summary of programs available in Minnesota.

CADI: Community Alternatives for Disabled Individuals

TBIW: Traumatic Brain Injury Waiver NF: Nursing

facility level NB: Neurobehavioral hospital level

CAC: Community Alternative Care for Chronically Ill Individuals

MR/RC: Home and Community-Based Services for Persons with Mental Retardation or Related Conditions
